#### **Rides this Summer**

**ABC:** Annapolis Bicycle Club will continue our Saturday morning rides. We expect to see the usual group of 'Fast, 30 to 50 miles, average speed 15 to 17 mph' riders out there. We also hope to have some riders in the 'Easy, 30 to 40 miles, average speed 12 to 15 mph' riders show up on Saturdays.

*Capital Bicycle:* They're planning some Wednesday evening rides from their store on Chinquapin Round Road. Call 410-626-2197 for more information as the weather warms up.

*HTO:* HTO in Westfield Shopping mall is planning on sponsoring Wednesday rides during April and May, starting April 11th. They will be easy rides on the B&A trail and will begin at 9:30 AM. *Ride for Shelter:* This one costs \$37 for an adult and \$15 for a child, but you get a great tour of the Annapolis area, a T-shirt, a goody bag, and it's for a *great* cause. ### **Bicycle Advocacy**

Several members have asked about what can we do to improve conditions and safety for cyclists. There are several places to find information on what's going on, and who to contact. One of the best sources for information is the Baltimore Spokes web site at <a href="www.baltimorespokes.org">www.baltimorespokes.org</a>. This site has information on pending action in the Maryland Legislature that affects all of Maryland. The site currently covers a law requiring a 3 foot passing distance when a vehicle passes a bicycle and a bill making it a misdemeanor to cause a death as a result of the person's driving, operating or controlling a vehicle or vessel in a criminally negligent manner. Other articles include a bill addressing the penalties for failure to yield the Right-of-Way, on the origins of One Less Car, and many other items.

**Bicycle Advocacy in Ann Arundel County -** Recently, your club has sent a letter to Ann Arundel County Executive John Leopold, urging him to limit expansion of the Town Point Dredge Material Placement facility near Deale. Expanding this facility would violate both State and County Critical Area rules, but of more importance to cyclists, it would result in more heavy truck traffic on Town Point, Fairhaven, and Leitch roads – all located south of Deale and which we nearly always use when cycling in that area while heading for North Beach.

#### Recalls

**SRAM Force Road Brake – Mounting Bolts:** Both front and rear mounting bolts can fail, resulting in loss of control and serious injury. Contact your dealer or for information.

*Cannondale 2007 Model Road Bicycles:* Bikes are recalled because the bike's front brake can fail. The recalled road bikes are made from aluminum and carbon fiber or all carbon fiber. They are sold in natural aluminum/carbon, red, black or black and blue. The recalled models include:

*Time Road Pedal Recall:* - The threaded bearing cap can come unthreaded from the pedal body and this can result in the pedal body coming off the pedal axle and bearing unit. ## Section of the B&A Trail Temporarily Closed

A 0.4 mile section of the trail was closed due to a washout but has now been reopened. ## Membership Application and Renewal Form

In consideration of accepting application for membership and being permitted to participate in any way in the activities of the Annapolis Bicycle Club, ("ABC"), I/WE, for myself/ourselves, my/our personal representatives, assigns, heirs and next of kin:

- 1. ACKNOWLEDGE, agree and represent that I/we understand the nature of Bicycling Activities and that I/we am/are qualified, in good health, and in proper physical condition to participate in such activities. I/we further acknowledge that certain of the activities will be conducted over public roads and facilities open to the public during the activities and upon which 1he hazards of traveling are to be expected. I/we further agree and warrant that if at any time I/we believe conditions to be unsafe, I/we will immediately discontinue further participation in the activity.
- 2. FULLY UNDERSTAND that (a) bicycling activities involve risks and dangers of serious bodily injury, including permanent disability, paralysis and death ("RISKS"); (b) these Risks and dangers may be caused by my/our own actions, or inactions, the actions or inactions of others participating in the activity, the condition in which the activity takes place, or the negligence of the "RELEASEES" named below, (c) there may be other risks and social and economic losses either not known to me/us or not readily foreseeable at this time; and I/we fully accept and assume all such

risks and all responsibility for losses, costs and damages I/we incur as a result on my participation in the activities of ABC.

3. HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE ABC, their administrators, directors, agents, officers, volunteers, and employees, other participants, and sponsors, advertisers, and, if applicable, owners and lessors of premises on which activities take place, (each considered one of the RELEASEES herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the RELEASEES or otherwise, including negligent rescue operations; and I/we further agree that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I/we, or anyone on my/our behalf, makes a claim against any of the RELEASEES, I/we will indemnify, save, and hold harmless each of the RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which any may incur as the result of such claim. I/we have read this agreement, fully understand its terms, understand that I/we have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect
